

**GOVERNMENT OF HARYANA

The Government of Haryana hereby constitutes Haryana State Narcotics Control Bureau headed by an ADGP/IGP rank officer under the overall control of Director General of Police, Haryana.

All police officers of the rank of ASI and above working in HSNCB shall be deemed to have been appointed under Section 7 of NDPS Act, 1985. Furthermore, all the officers/officials working in HSNCB shall be subject to general control and direction of the DGP, Haryana as envisaged in Section 7(2) of NDPS Act, 1985.

**Objectives:-**

The Haryana State Narcotics Control Bureau would dedicate itself to prevention and control of drugs trafficking in Haryana and detection and criminal prosecution of all those indulging in drug peddling. Supply, manufacturing, transportation, distribution and storage of drugs and narcotics substances in the State.

**Functions:-**

The broad functions of the Special Task Force would be as follows:-

1. To develop strategies, measures and methods to enforce the law against drug trafficking, prevent drug abuse and co-ordinate with other governmental agencies to achieve these objectives.
2. To work in co-ordination with the District Police, GRP and other police units such as STF and SCB.
3. To collect technical/human intelligence and maintain surveillance in accordance with the existing provision of law over anti-social elements involved in drugs/narcotics trafficking, and plan and execute special operations against drug-traffickers through special teams and also in association with other units of Haryana Police as well as other departments of the Government.
4. To Commission or conduct data analysis and make recommendations to the higher authorities.
5. Develop actionable intelligence and act on such intelligence to enforce the Narcotic Drugs and Psychotropic Substance Act 1985 and all related criminal and civil laws to sever the drug supply lines by taking stringent action against the drug suppliers, dealers and peddles.
6. Guide and coordinate the action of the District Police/other Police units in enforcement of illicit traffic in Narcotic Drugs and Psychotropic Substances Act 1988 and all related criminal and civil laws.
7. To Maintain suitable liaison and coordination with NCB and ED for effective enforcement and prevention of illicit Traffic in Narcotic Drugs and Psychotropic Substances Act, 1985, PITNDPS Act 1988 and all related criminal and civil laws in Haryana State.
8. The HSNCB shall primarily focus its efforts on detection of gangs and financiers involved in large scale drug smuggling operations rather than on petty, localised trafficking. It shall also focus on seizure and confiscation of assets and property amassed by such financiers and smugglers out of proceeds of crime under relevant provisions of NDPS Act. It will also be responsible for utilizing the provisions of PITNDPS Act against habitual/hardened leaders and members of drug trafficking gangs.

9. The HSNCB would aim to catch big dealers and distributions of drugs to eliminate the drugs menace from the state. However, the consumers and addicts would be dealt with compassion and sympathy in accordance with law to ensure their de-addiction and rehabilitation.
10. HSNCB shall maintain crime statistics, data and other details pertaining to enforcement of NDPS Act and criminals involved in drug/narcotics trade. For this purpose the HSNCB would be provided copies of all periodical/statistical report being sent to the State Crime Branch by the districts and other units.
11. To perform such other duties as may be assigned by the DGP from time to time.

**Logistics-**

- i. The HSNCB would be provided dedicated staff by the Police Department to carry out its task which would be considered on deputation in HSNCB.
- ii. The Haryana State Narcotics Control Bureau would be provided arms and ammunition, communications equipments, vehicles, technical gadgets and other special equipments, if any, by the Police Department through DGP Crime.
- iii. The Haryana State Narcotics Control Bureau would be allowed to use Kot/Malkhana/Stores/of Districts Police/HAP or IRB Battalions for maintenance and storage of arms, ammunition etc.
- iv. The resource support including men, material and machines required by Haryana State Narcotics Control Bureau would be provided by the Police Department through DGP Crime.
- v. The Haryana State Narcotics Control Bureau, if so required, engage on deputation basis or hire, professional/special expert/consultant services/Scientific Services etc. as deemed fit with prior approval of competent authority.
- vi. The Financial support, if required for the Haryana State Narcotics Control Bureau would be provided by the department of Police through DGP Crime.

**Investigation:-**

- A. The HSNCB would register the FIRs in local police stations under the provisions of Narcotics Drugs and Psychotropic Substances Act, 1985. The Prevention of Illicit Trafficking in Narcotics Drugs and Psychotropic Substances Act, 1988 and other related laws.
- B. All police units/districts/GRP shall assist the Haryana State Narcotics Control Bureau in all aspects related to investigation.
- C. The DGP may transfer investigation of NDPS cases to HSNCB.

**Reporting and review:-**

- a) The Haryana State Narcotics Control Bureau would submit monthly progress reports to Home Secretary/ACS(Home) through DGP (Haryana).
- b) DGP (Crime) shall regularly review the performance of officials of HSNCB and take necessary action to improve the performance of HSNCB.
- c) The Government may review the progress/action/interventions of HSNCB as per the need.
- d) HSNCB shall submit reports, data and analytics to the DGP(Crime), DGP (Haryana) or Government as and when required to do so.

**Headquarters of HSNCB:-**

The Headquarter of HSNCB shall be in Haryana Police Complex, Madhuban, Karnal.

**Controlling Officer:-**

The Additional Director General of Police, the State Narcotics Bureau, Haryana shall report to the Additional Chief Secretary (Home) through the Director General of Police, Haryana who shall be his controlling officer.
