

### ORDER OF THE GOVERNOR OF HARYANA

Attar Singh, Deputy Superintendent; if they are exonerated after the final decision of disciplinary proceedings under rule-7 of Haryana Civil Services (P&A) Rules, 1987 pending against them and are found fit for promotion with retrospective effect.

The promotion of above mentioned Superintendents from the post of Deputy Superintendent are also subject to the condition that if any Deputy Superintendent under disability quota are found eligible then the Junior most Superintendent will be reverted to his/her former post i.e. Deputy Superintendent without any notice.


