No. 11059/01/2014-AIS-III (Part) dated 15.06.2022 received from Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training has revised the timelines for recording PAR for the year 2021-22 has been extend by giving relaxation in rule 5(1) read with schedule 2 of AIS (PAR) Rules.

2. Now, keeping in view of the directions issued by the Government of India, the State Government has revised the timelines for writing the PARs of IPS officers for the year 2021-22. The timelines as mentioned below in Para 9 of Govt. letter dated 07.06.2022 is hereby modified as under:-
