PART I-GENERAL

- I. These rules may be called the Haryana Forensic Science Group B Short title,
- 2. In these rules unless the context otherwise requires,-

- (i) any University incorporated by law in India;
 (ii) in the case of degree or diploma or certificate obtained as a result of examinations held before the 15th August, 1947, the Punjab,
- (iii) any other University which is declared by the Government to be a recognised University for the purpose of these rules;
- (g) "Service" means Haryana Forensic Science Group B Service.

PART II-RECRUITMENT TO SERVICE

3. The service shall comprise the posts shown in Appendix A to these Number and character of posts.

Provided that nothing in these rules shall affect the inherent right of the Government to make additions to or reduction in the number of such posts or to create new posts with different designations and scales of pay, either permanently or temporarily.

- 4. (1) No person shall be appointed to the service unless he is—
 - (a) a citizen of India, or

- (b) a subject of Niepal, or
- (c) a subject of Bhutan, or
- (d) a Tibetan refegee who came over to India before the 1st January, 1962, with the intention of permanently settling in India, or
- (e) a person of Indian origin who has migrated from Pakistan, Buenet, Sri Lanka, East African Countries of Kenya, Uganda, the United Republic of Terizania (formerly Tanganyika and Zanzitar), Zambia, Malawi, Zaire and Ethiopia with the intention of permanently settling in India:
- Provided that a person belonging to category (b), (c), (d), or (e) shall be a person in whose favour a certificate of eligibility has been issued by the Government.
- (2) A person in whose case a certificate of eligibility is necessary may be admitted to an examination or interview conducted by the Commission or any other recruiting authority, but the offer of appointment may be given only after the necessary eligibility certificate has been issued to him by the Government.
- (3) No person shall be appointed to the Service by direct recruitment unless he produces a certificate of character from the principal academic officer of the University, college or institution last surended, if any, and similar certificates from two other responsible persons, not being his relatives, who are well acquainted with him in his private life and are unconnected with his university, college or institution.

Age.

- 5. No person shall be appointed to the service by direct recruitment who is less than 20 years or more than 45 years of age on or before the 1st day of February next preceding the last date of submission of applications to the Commission:
- Provided that in the case of regular Government employees other than ad hoc employees, who are appointed by transfer, there
- Provided further that upper age limit shall be relaxable in the case of Scheduled Castes, Scheduled Tribes, Backward Classes and Ex-Servicemen in accordance with the instructions issued by the State Government in this behalf from time to time.

- (3) On the completion of the period of probation of a person, the appointing authority may,-
 - (a) If his work or conduct has, in its opinion, been satisfactory,
 - (i) confirm such person from the date of his appointment, if appointed against a permanent vacancy; or
 - (II) confirm such person from the date from which a permanent. vacancy occurs, if appointed against a temporary vacancy;
 - (lii) declare that he has completed his probation satisfactorily, If there is no permanent vacancy; or
 - (b) if his work or conduct has, in its opinion, been not satisfactory,—
 - (i) dispense with his services, if appointed by direct recruitment, if appointed otherwise, revert him to his former post or deal with him in such other manner as the terms and conditions of previous appointment permit; or
 - (ii) extend his period of probation and the reafter pass such order, as it could have passed on the expiry of the first period of probation; provided that the total period of probation, including extension, if any, shall not exceed three years.

Seniority o f members of Service.

11. Seniority, inter se, of members of the Service shall be determined by the length of contiunous service on any post in the Service:

Provided that in the cases of members appointed by direct recruitment, the order of merit determined by the Commission, shall not be turbed is living the seniority:

Provided further that in the case of two or more members appointed on the same date, their seniority shall be determined as follows :-

- (a) a member appointed by direct recruitment shall be senior to a member appointed by promotion or by transfer;
- a member appointed by promotion shall be senior to a member appointed by, transfer;
- (c) In the case of member: appointed by promotion or by transfer, seniority shall be determined according to the seniority of such members in the appointments from walch they were promoted or transferred; and

(d) in the case of members appointed by transfer from different cadres, their senority shall be dite mined according to pay, preference being given to a member, who was drawing a higher rate of pay in his previous appointment, and if the rates of pay drawn are also the same then by the length of their service in the appointments, and if the length of such service is also the same, the older member shall be senior to the younger member.

12. A member of the Service shall be liable to serve at any place Liability to whether within or outside the State of Haryana.

A member of the Service may also be deputed for scrvice as under :-

- (1) a company, association or body of individuals whether incorporated or not, which is wholly or substantially owned or controlled by the State Government, a municipal corporation or a local authority within the State of Haryana;
 - (ii) the Central Government or a company, association or body of Individuals whether incorporated or not, which is wholly or substantially owned or controlled by the Central Government; or
- (fil) another State Government, an international organisation, an autonomous body not controlled by the Government, or a private body:
 - Provided that no member of the Service shall be deputed to the Central or any other State Government or any organisation or body referred to in clauses (ii) and (iii) except with his consent.
- 13. In respect of pay, leave, pension and all other matters, not ex-Leave, penpressely provided for in these rules, the member of the Service sion, other shall be governed by such rules and regulations as may have been matters. or may hereafter be adopted or made by the competent authority under the Constitution of India or under any law for the time being in force made by the State Legislature.
- 14. (1) In matters relating to disopline, penalties and appeals, mem Discipline, bers of the service shall be governed by the Punjab Civil Services penalties (Punishment and Appeal) Rules, 1952, as amended from time to and time:

Provided that the nature of penalties which may be imposed, the authority empowered to impose such penalties and appellate authority shall, subject to the provisions of any law or rules made under article 309 of the Constitution of India, be such as are specified In Appendix C to these rules.

(2) The authority competent to pass an order under clauses (c) and (d) of sub-rule (1) of rule 10 of the Punjah Civil Services (Punishment and Apoals) Rules, 1952 shall also be as specified in Apondix D to these rules.

Vaccination

15. Every member of the Service shall get himself vaccinated and revaccinated if and when the Government so directed by a special or general order.

Onth of allagiance.

16. Every member of the Service, unless he has already done so, shall be required to take the oath of allegiance to India and to the Constitution of India as by law established.

Power of relaxation.

17. Where the Government is of the opinion that it is necessary of expendient to do so, it may, by order for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

Special provision.

18. Notwithstanding anything contained in these rules, the appointing authority may impose special terms and conditions in the order of appointment if it is downed expedient to do so.

Repeal and saying:

19. Any rule applicable to the Service and corresponding to any of these rules which is in force immediately before the commencement of these rules is hereby repealed:

Provided that any order made or action taken under the rules so repealed shall be deemed to have been made or taken under the corresponding provision of these rules.

- 1. (1) These rules may be called the Haryana Forensic Science Group B Service (Amendment) Rules, 2003.
- (2) They shall come into force on the date of their publication in the official Gazette.
- 2. In the Haryana Forensic Science (Group B) Service Rules, 1980 (hereinafter called the said rules), in rule 2,-
 - (i) after clause (c), the following clause shall be inserted, namely:

 - (ii) by direct recruitment; or
 - (iii) by transfer or deputation of an officer already in the service of any State Government or the Government of India;
 - (b) in case of Senior Scientific Officer (General)—
 - (i) by promotion from amongst Senior Scientific Assistant General/ Chemistry/Physics/Biology/Serology/Ballistics/Documents; or
 - (ii) by direct recruitment; or
 - (iii) by transfer or deputation of an officer already in the service of any State Government or the Government of India;

- (c) in case of Senior Scientific Officer (Scene of Crime)-
 - (i) by promotion from amongst Senior Scientific Assistant (Scene of Crime); or
 - (ii) By direct recruitment; or
 - (iii) by transfer or deputation of an officer already in the service of any State Government or the Government of India.

No.G.S.R.26/Const./Art.309/2012.-- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Forensic Science (Group B) Service Rules, 1980, namely: --

- (1) These rules may be called Haryana Forensic Science (Group B) Service (Amendment) Rules, 2012.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- In the Haryana Forensic Science (Group B) Service Rules, 1980 (hereinafter called the said rules), in rule 9, in sub-rule (1), for clauses (a), (b) and (c), the following clauses shall be substituted, namely:--
 - "(a) in case of Senior Scientific Officer (Chemistry, Physics, Biology, Serology, Ballistics, Documents, Lie-Detection, NDPS, DNA, Photo, Scene of Crime, Toxicology, Cyber Forensic, Explosive),-
 - by promotion from amongst Senior Scientific Assistants of concerned divisions; or
 - (ii) by direct recruitment; or
 - (iii) by transfer or deputation of an officer already in the service of any State Government or the Government of India;"
 - "(b) in case of Senior Scientific Officer (Psychology),-
 - by promotion from amongst Senior Scientific Assistants (Psychology/Lie-Detection); or
 - (ii) by direct recruitment; or
 - (iii) by transfer or deputation of an officer already in the service of any State Government or the Government of India;"
 - "(c) in case of Senior Scientific Officer (Diatomology),-
 - by promotion from amongst Senior Scientific Assistants (Diatomology/Biology); or
 - (ii) by direct recruitment; or

- (iii) by transfer or deputation of an officer already in the service of any State Government or the Government of India;".

- **No. G.S.R. 19/Const./Art. 309/2021.** In exercise of the powers conferred by the provision to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Forensic Science (Group B) Service Rules, 1980, namely:—
- 1. These rules may be called the Haryana Forensic Science (Group B) Service (Amendment) Rules, 2021.
- 2. In the Haryana Forensic Science (Group B) Service Rules, 1980 (hereinafter called the said rules), for rule 14, the following rule shall be substituted, namely:-
 - "14. Discipline, penalties and appeals.- (1) In matters relating to discipline, penalties and appeals, members of the Service shall be governed by the Haryana Civil Services (Punishment and Appeal) Rules, 2016, as amended from time to time:

Provided that the nature of penalties which may be imposed, the authority empowered to impose such penalties and appellate authority shall, subject to the provisions of any law or rules made under article 309 of the Constitution of India, be such as are specified in Appendix C to these rules.

- (2) The authority competent to pass an order under clause (c) or clause (d) of rule 9 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016 and the appellate authority shall be such as specified in Appendix D to these rules."
- 3. In the said rules, for Appendix A, the following Appendix shall be substituted, namely:-

- (ix) against serial number 14, in item (i), the words "with specialization in Chemistry" shall be omitted;
- (x) for the words "Hindi upto Matric" and "Hindi/Sanskrit upto Matric standard or Higher education" wherever occurring, the words "Hindi or Sanskrit as one of the subject in Matric or Higher Education" shall be substituted.
