Subject: Compliance of notification relating to 'Designated Places' for examination of witness through audio-video electronic means as mandated under Section 265, Section 266 and Section 308 of the Bhartiya Nagrik Suraksha Sanhita (BNSS), 2023.

Sir/Madam,

In continuation of Government letter of even No. dated 05.02.2025 on the subject noted above.

2. The matter has been re-considered and it has been decided that following officials can be nominated as 'Coordinator' at the designated places notified vide Government Notification dated 31.01.2025:-

- i. In every office where there is no sanctioned post of Superintendent or Deputy Superintendent or where the post is vacant, in that situation Senior most Assistant/Section Officer in place of Superintendent or Deputy Superintendent be nominated as Coordinator for the subject mentioned purpose.
- ii. In every office of SDM, ASR may be nominated as coordinator.
- iii. In the police stations, MHC of the police station may be nominated as coordinator for subject mentioned purpose.
- iv. Whenever any coordinator is on leave or not available in office, in that eventuality, all Head of the offices where designated place is to be established may be permitted to nominate any official who is a Govt. employee and not contractual staff as coordinator, for above purpose.

3. The above instructions shall be complied strictly within in letter & spirit.
