**ORDER**

In continuation of Haryana Government Notification No. 5/1//2020(I)-2HC and No. 5/1/2020(II)-2HC, dated 11.08.2023 and No. 5/54/2023-2HC, dated 13.12.2023 vide which Advisory Board(s) Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances (PITNDPS) Act, 1988, Conservation of Foreign Exchange and Prevention of Smuggling Activities (COFEPOSA) Act, 1974 And National Security Act, 1980 constituted respectively. The Governor of Haryana is pleased to fix the following terms and conditions of Chairperson and Members of the Advisory Board(s) of Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances (PITNDPS) Act, 1988, Conservation of Foreign Exchange and Prevention of Smuggling Activities (COFEPOSA) Act, 1974 And National Security Act, 1980 :-

**(1) Tenure:**

In the first instance, the Tenure of the Chairperson and Members will be two years from the date of assuming charge. The Government may, however, curtail the period of tenure at anytime or extend it from time to time.

**(2) Remuneration :**

1.	Chairperson	To draw Salary permissible to a sitting Judge of the Punjab & Haryana High Court (Minus Pension) + DA admissible from time to time
2.	Member (Judicial)	-Do-
3.	Member (non- Judicial)	Rs.1,00,000/- per month (fixed).

**(3) Fixed Sumptuary Allowance:-**

1.	Chairperson	Rs.5,000/- P.M.
2.	Members	Rs.3,000/- P.M.

**(4) Reimbursement of Mobile recharges bill:**

The Chairperson and Members shall be allowed to use a phone/mobile for which monthly reimbursement of Mobile recharge bill not exceeding Rs.650/- subject to condition that they have not claimed any phone/mobile bill charges from Hon'ble High Court of other department.

**(5) Transport:-**

The Government provide Government vehicle to the Chairperson and Members. In case, they will not use Government vehicle they shall be entitled to use her/his personal car attending the meeting for which travel charges @ Rs.16 per Km as prescribed in Finance Department, Haryana's orders No. 5/27/98-1FR(FD) dated 20.06.2018 and amended from time to time.

**(6) Travelling allowance/Daily Allowance:**

The Chairperson and Member (Judicial) shall be entitled travelling allowance/daily allowance as admissible to the Judge of High Court and the Member (Non-Judicial) shall be entitled travelling allowance/daily allowance as per entitlement of Grade-I officers of State Services in Haryana Civil Services (Travelling Allowance) Rules, 2016 as amended from time to time.

**(7) Infrastructure:**

Infrastructure including space for office, staff, furniture, computers with printers, Photostat machine, telephone facility along with internet etc. shall be provided by the Government/Police Department as per requirement of Advisory Board.

**(8) Staff for Advisory Board:**

The requisite staff will be provided by the Government/Police Department as per Board's demand by Posting of staff or engaged through Outsource Policy.

**(9) Mode of payments:**

The payment of remunerations, Travelling Allowance and other expenditure etc. shall be made by the Director General of Police, Haryana under Budget Head/Scheme of Police Department 'P-01-05-2055-51-001-96-51-Advisory Boards'.

**(10) Power to relax:-** Where the State Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions as described above.
