

## ORDER OF THE GOVERNOR OF HARYANA

The following Superintendents of Haryana Civil Secretariat are hereby promoted as officiating Under Secretaries to Government, Haryana in the Level-11 of Pay Matrix of Haryana Civil Services (Revised Pay), Rules, 2016 on purely temporary basis with effect from the date they assume the charge of their new assignment as such:-

1.	Sangita Devi D/o Sh. Satbir Singh	Subject to the condition that nothing is recorded against her integrity in her awaited A.C.R. for the year 2022-23.
2.	Sangita Sharma W/o Sh. Tejinder Kumar Sharma	Subject to the condition that nothing is recorded against her integrity in her awaited A.C.R. for the year 2022-23.
3.	Suresh Kumar S/o Sh. Karan Singh (SC)	Subject to the condition that nothing is recorded against his integrity in his awaited A.C.R. for the year 2022-23.
4.	Naresh Kumar S/o Late. Sh. Sadhu Ram (SC)	Subject to the condition that nothing gets recorded against his integrity in his awaited A.C.R. for the year 2022-23.

2. The above promotions are subject to the following conditions:-

- If any Under Secretary(s) working against ex-cadre post is posted against the cadre post and the number of Under Secretaries increased beyond the sanctioned strength, then junior most Under Secretary(s) will be reverted to his/her former post i.e. Superintendent, without any notice.
  - They shall have no right of seniority over and above their seniors who are facing departmental proceedings and who will later on exonerated after the final decision of said proceeding and found fit for promotion.
  - If any Superintendent under disability quota is found eligible then the junior most Under Secretary will be reverted to his/her former post without any notice.
  - If any Superintendent under Reservation Policy dated 07.10.2023 is found eligible then the junior most Under Secretary will be reverted to his/her former post without any notice.
  - Promotion of all above officers shall be subject to the condition of final outcome of Sh. Jarnail Singh's case pending in the Hon'ble Supreme Court of India .
3. They will be on probation for a period of one year.
4. Their posting orders will be issued separately.


