Notification

No. S.O. 50/C.A. 32/2012/S. 28/2025.— WHEREAS, vide Haryana Government, Women and Child Development Department, Notification No. 444SW(3), dated the 29th May, 2013, the Governor of Haryana designated all the Session Judges and Additional Session Judges, except the Additional Session Judge (Ad-hoc, Fast Tract Courts), at each district headquarter, to be a Special Court under the Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012) to try the offences under the said Act;

AND, WHEREAS, the Hon'ble Supreme Court of India in Suo Moto Writ Petition (Criminal) No. 1/2019 directed that in each district of the country, if there are more than hundred cases under the Protection of children from Sexual Offences Act, 2012 (Central Act 32 of 2012), an exclusive/designated Special Court shall be set up, which shall try no other offences except those under the said Act:

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 28 of the Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012), the Governor of Haryana in consultation with the Chief Justice of the Punjab and Haryana High Court, hereby establishes one court of Additional Session Judge each in districts of Panchkula and Gurugram and two courts of Additional Session Judge in district Faridabad to try the offences exclusively under the said Act as Special Court.

Note: The above established Courts shall be in addition to the Courts established *vide* Haryana Government, Administration of Justice Department, notification No. S.O.7/C.A.32/2012/S.28/2020, dated the 17th January, 2020.
