In view of prevailing situation along the western border of the country, the
preparation of Civil Administration against hostile attacks and adoption of Civil Defence
precautionary measures in the State is inevitable.

- 2. Therefore, amid potential threat of apprehended attack by air, in exercise of the power conferred under clause (I) of Rule 14 of Civil Defence Rules, 1968 made under Section 3 of the Civil Defence Act, 1968 (Central Act 27 of 1968), the State Government hereby prohibits use/flying of any unmanned Aerial Vehicles (UAV) like drones within territorial jurisdiction of State of Haryana from 10.05.2025 to 25.05.2025 except use thereof by Indian Armed Forces, CAPF's, State Police, NDRF and SDRF.
- 3. All Commissioners of Police/ Superintendents of Police in the State shall be responsible for the enforcement of the above order and to take action in case of violation of direction of this orders as per law.
- 4. This order shall be promulgated through out the limits of State of Haryana by announcement through the print and electronic media by District Information & Public Relation Officers of each district and by affixing the copy of this order on the notice board in all the Courts, Sub-Divisions, Tehsils, Police Stations and other public places in the State.
