(PUBLIC EMERGENCY OR PUBLIC SAFETY) RULES, 2017

1. Whereas, it appears to me that there is likelihood of causing tension, annoyance, obstruction or injury to persons, danger to human life and property, disturbance of public peace & tranquility within the limits of State of Haryana by protestors/agitators/gangsters/miscreants, anti-national and anti-social elements, in view of the forthcoming verdict to be announced by the CBI Special Court, Panchkula, in the case relating to Sant Ram Rahim Gurmeet Singh, Head of Dera Sacha Sauda, Sirsa on 25th August, 2017.
2. And whereas, there is an imminent danger of loss of life and/or damage to public/private property, and widespread disturbances to public tranquility and communal harmony, as a result of inflammatory material and false rumours, which are being/could-be transmitted/circulated to the public through social media/messaging services on mobile internet services (2G/3G/4G/CDMA/GPRS), all SMS services and all dongle services.
3. And, whereas, to thwart the designs and activities of anti-national and anti-social groups/elements and maintain peace and communal harmony in the border State of Haryana, and to prevent any loss of life or damage to public/private property, it has become necessary to take all necessary steps and measures to maintain Law and Order in the State of Haryana in public interest, by stopping the spread of disinformation and false rumours, through various social media platforms, such as Whatsapp, Facebook, Twitter, etc. on mobile phones and SMS, for facilitating and/or mobilization of mobs of agitators and demonstrators, who can cause serious loss of life and/or damage to public/private property by indulging in arson/vandalism and other types of violent activities.
4. Now, therefore, in exercise of powers conferred upon me by virtue of Rule 2 of Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017, I Home Secretary, Haryana do hereby order suspension of the (i) Mobile internet services (2G/3G/4G/CDMA/GPRS), (ii) all SMS services and (iii) all dongle services etc. provided on mobile networks **except voice calls** in the territorial jurisdiction of State of Haryana. Haryana Telecom Services providers and Head of BSNL (Haryana jurisdiction) are hereby directed to ensure compliance of this order.
5. This order is issued to prevent any disturbance of peace and public order in the jurisdiction of State of Haryana and shall be in force for the **next three days**, from the time this suspension order becomes operational.
6. This order is being passed ex-parte in view of the emergent situation. It shall be published for the information of public through press and means of communication.
7. Any person found guilty for violation of aforesaid order, will be liable for legal action.

Haryana Telecom Services providers and Head of BSNL (Haryana jurisdiction) are hereby directed to ensure compliance of this order for the entire jurisdiction of State of Haryana.



Subject:- Handling of potential Law & Order situation that may arise in view of the judgement of Hon'ble Supreme Court judgment on the Ramjanmabhommi-Babri masjid land dispute and temporary & partial suspension of Telecom Services under 'Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017'.

Reference on the subject noted above.

2. As you are aware that the verdict is likely to be pronounced by the Hon'ble Supreme Court on the Ramjanmabhommi-Babri masjid land dispute anytime in the near future. Possibility of untoward and incidents Law & Order situation aftermath the pronouncement of the verdict cannot be ruled out.
3. All efforts must be made to not only collect intelligence but also to monitor social media sites to trace any incinerating comments / posts thereby. All celebrations and mourning before or aftermath of the order is hereby prohibited and no one is allowed to block or create any hindrances along national highways, state highways or railroads.
4. In view of possibility of breach of public tranquility it is directed that that Mobile internet services (2G, 3G, 4G and CDMA services) including SMS services and dongle services be suspended in the areas of entire districts of Nuh, Yamunanagar & Palwal and in subdivisions of Sohna in Gurugram District and Hathin of Palwal.
